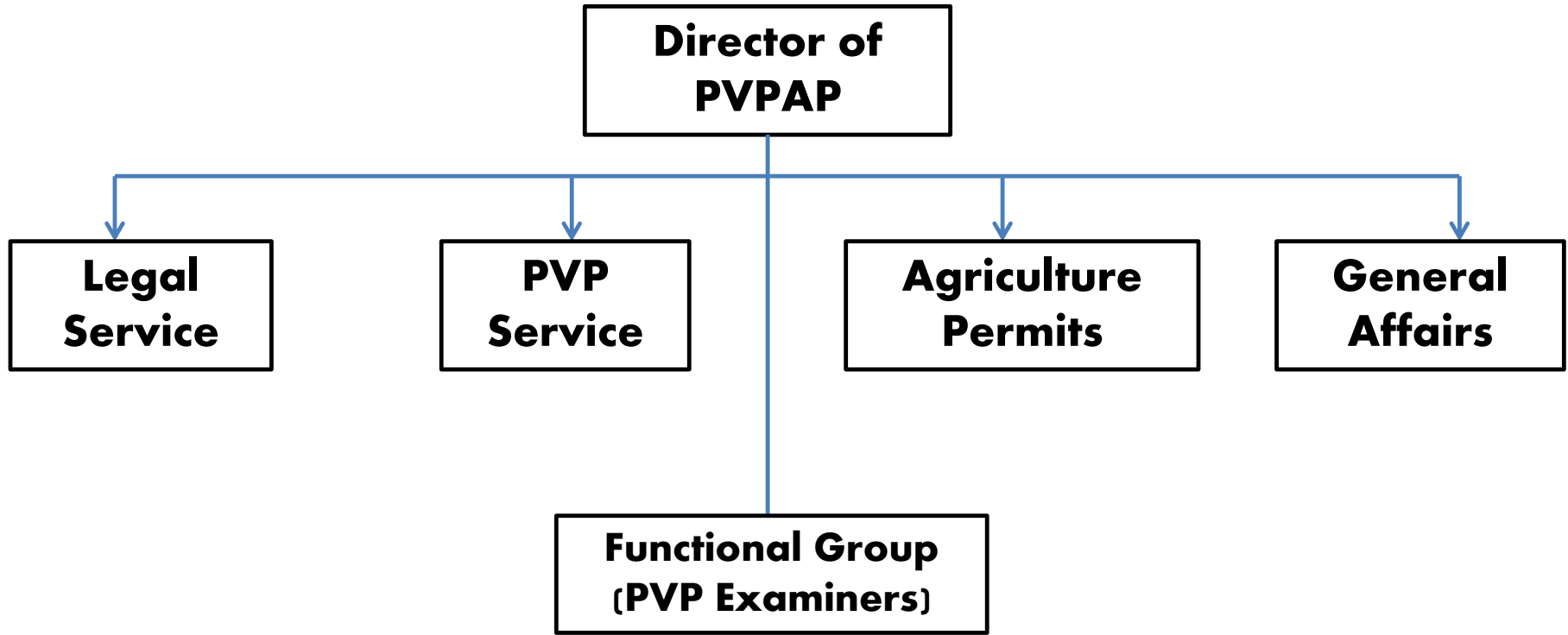
LEGAL BASIC OF INDONESIA PVP SYSTEM

1. Indonesia National Law No 29 year 2000 concerning Plant Variety Protection
2. Government Regulation No 13/2004 concerning Requirements and Procedure of Tranfer of PVP Right and Use of The Protected Varieties
3. Agriculture Minister Regulation No 121/2013 concerning Requirements and Procedure of The PVP Right Granting

Content of Legal Basic

- To protect all genera and species
- Duration of protection:
 - 20 years for annual crops
 - 25 years for perennial crops
- Requirements for a protection
 - Novelty
 - Distinct
 - Uniform
 - Stable
 - Denomination

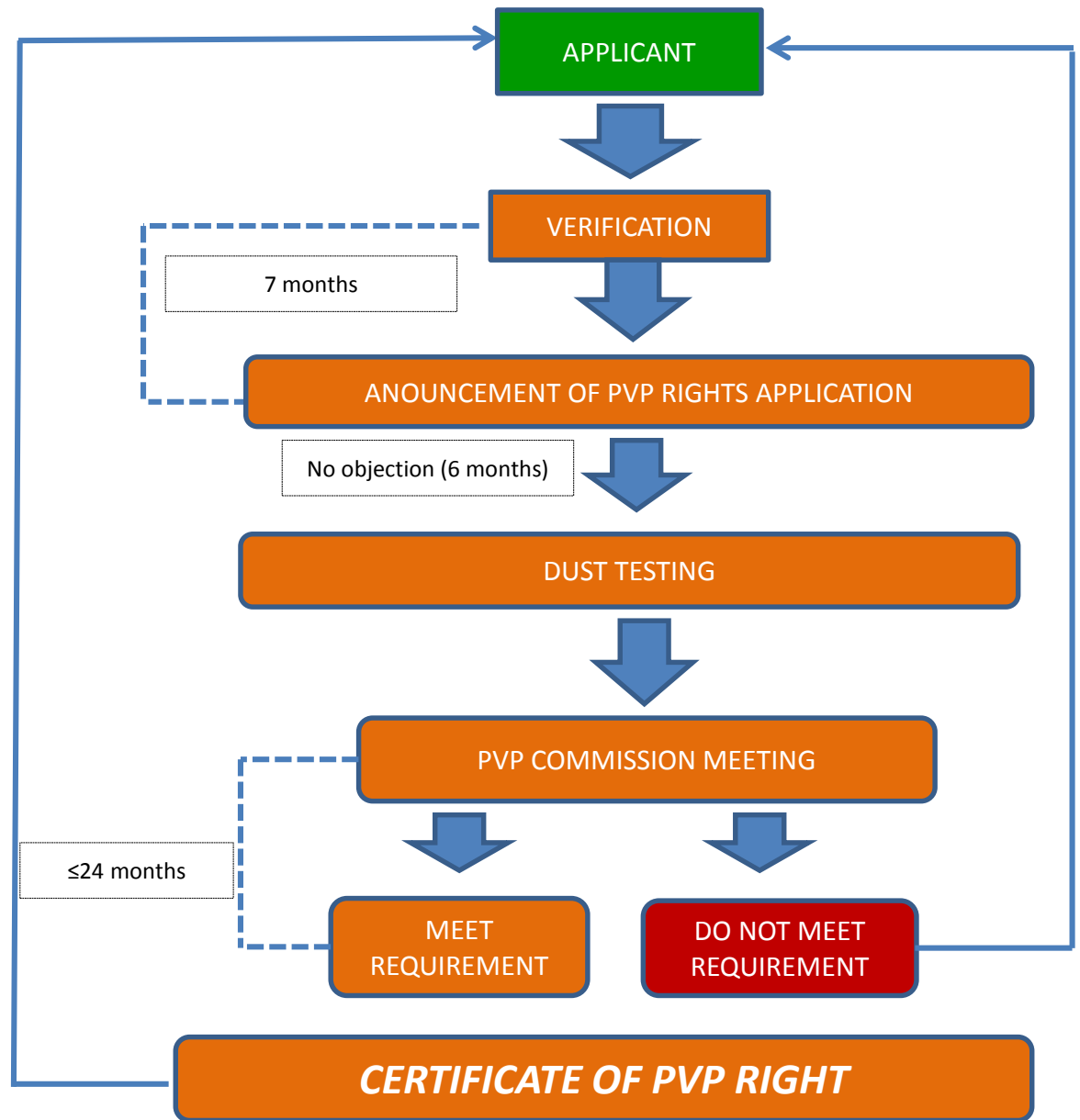
ORGANIZATION

- 6 PVP Examiners
- 48 crops expert from Research Institute to give technical assistance the PVP Examiner (**if necessary**)
- 17 Supporting Staffs (administrative, certification)
- DUS Test Station for highland crops (Lembang, West Java)
- 84 Technical Guidelines

PROCEDURE PVP APPLICATION



DUS Test Method

- I. Official Test (Growing test)**
- II. Breeder testing/On site examination**
- III. Document examination/taking over report**

I. Official Test

- Conduct in Official DUS Test Station
- Located in Lembang West Java
(At present especially for Highland Crops)
- Since May 2014
- In September 2015, 6 varieties will be conducted in DUS station
 - ✓ 2 varieties of Capsicum
 - ✓ 3 varieties of Potato
 - ✓ 1 variety of Cucumber

II. Breeder Test

- For lowland & Middle Land Crops
- Particularly Perennial Crops
- Applicant conduct the trial according to the proposal from PVP examiner
- PVP examiner visit to applicant site to examine the varieties (1-3 times visit depend on crops)

III. Document Examination/ Taking over Report

- ❖ **Mostly for foreign application**
- ❖ **Buy DUS report from trusted & authorized institution, whereas DUS test report available**
- ❖ **Specially for perennial crops/trees, or species which can't grow well in indonesia**
- ❖ **Supported database description needed**
- ❖ **Image analysis**

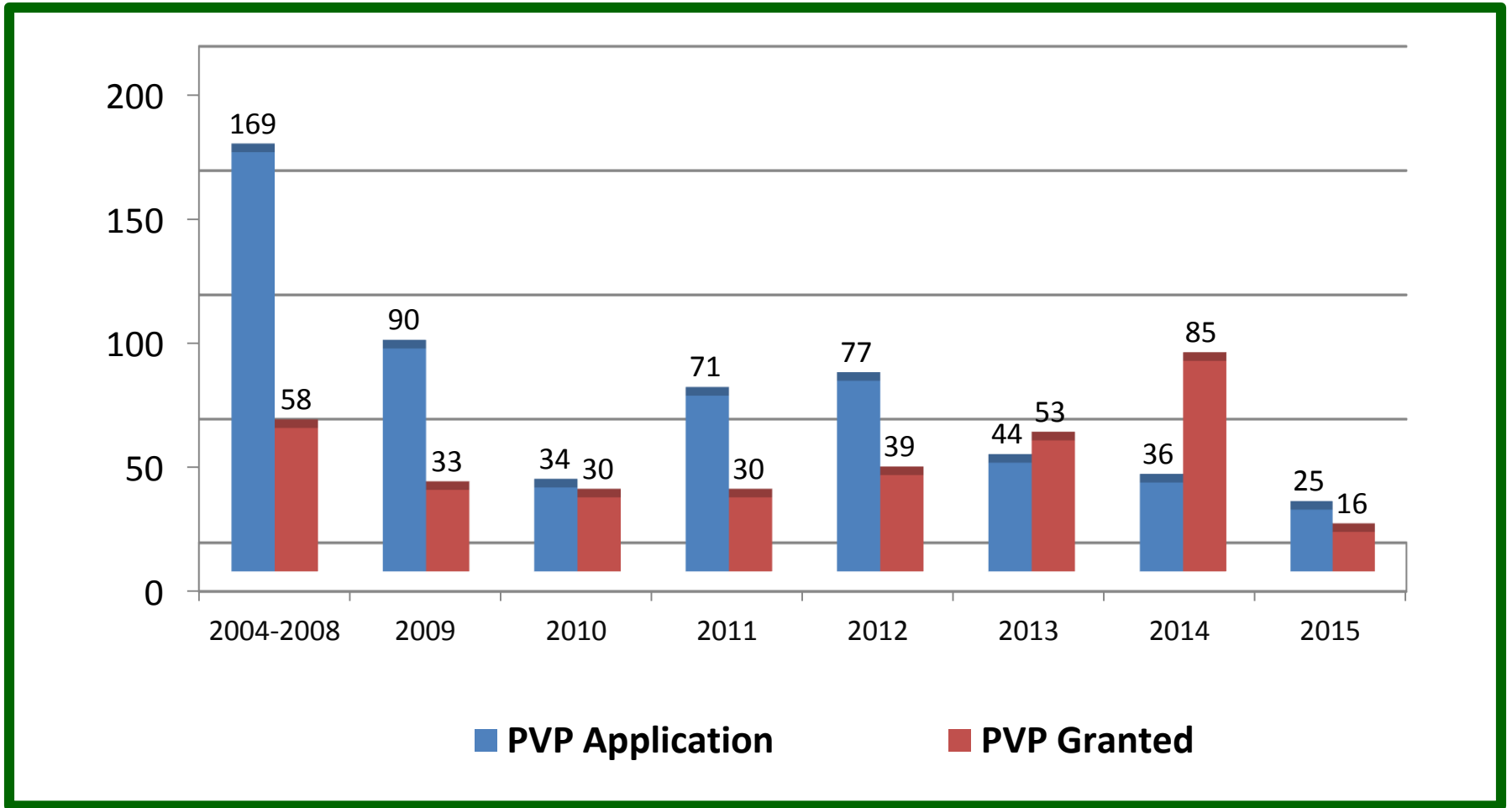

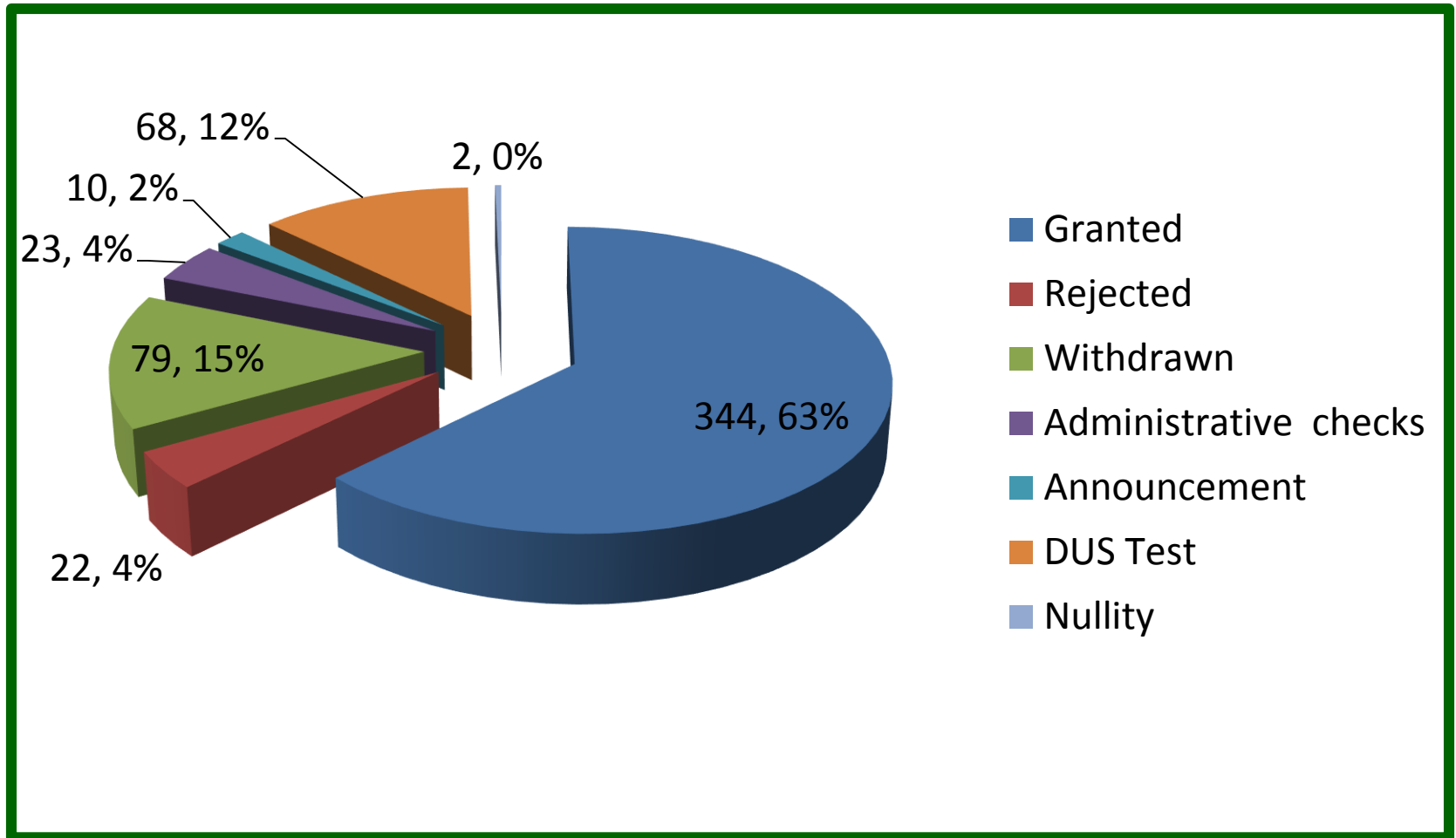

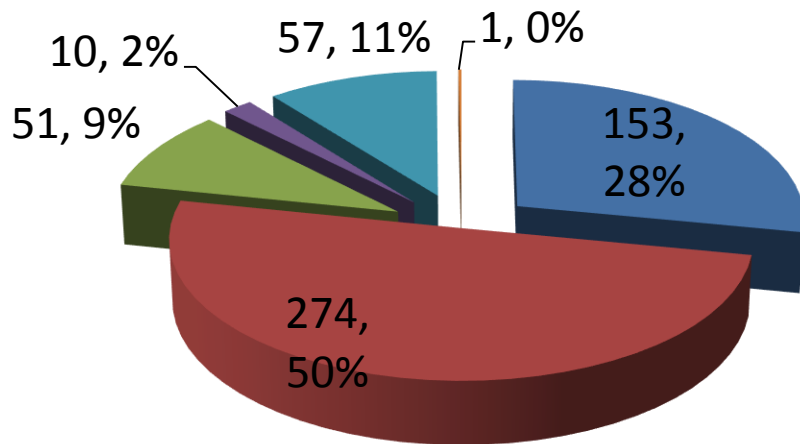

Type of Status PVP Application

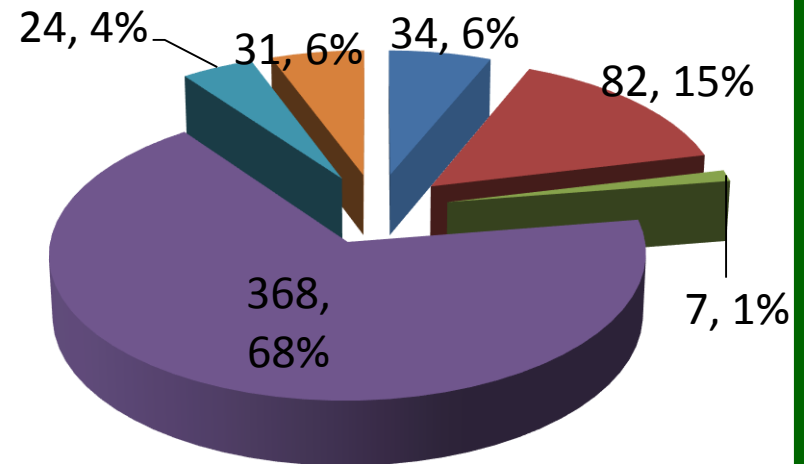


TYPE OF CROPS PVP APPLICATION
