




THE STATUS OF PVP APPLICATIONS (2004 - JULY 2014)




DEVELOPMENT OF PVP APPLICATION AND GRANTING BY YEAR (2004 – JUNE 2014)



PVP APPLICATION BY CROP




PVP GRANTING BY CROPS (TOTAL 270 VARIETIES)






DETAIL FIGURE OF PVP GRANTING


