- 1) Under the UPOV Convention, do the new plant varieties of OPV, Hybrid and GMO have any difference conditions?
- 2) Cambodia always considers the financial support and technical assistant from UPOV and The Ministry of Agriculture Forestry and Fisheries of Japan as the one priority to help accelerate the operation of the Plant Variety Protection.

- 4) Plant breeder based on the agricultural areas, environmental conditions and plant variety's imports, Will they be able to solve the problem of plant variety in Cambodia and increase the agricultural productivity?
