

#### **1. Agricultural Development in Lao PDR**



Lao PDR covers area of 236,800 km2 Population is about 6.51 million (In 2012); Cultivated land covers about 2 million ha (5%), rice is occupying 60-70%

Lao PDR is largely an agrarian society with 80% of people living in rural areas.

Major crops in the country are mainly rice, maize, Cassava, fruits, vegetables, and others...

Agricultural Law (No. 01/98 NA, Promulgated by National Assembly on 10 October 1998,). This law is now under improving/review process..

 Regulation on Management and Use of Plant Variety (Ministry Agreement, No.3919/MAF, 12 December 2012).

#### **Policy:**

The state promotes, encourages persons, juristic persons, organizations to invest in developing and controlling plant variety with focus on construction of technical infrastructure, capacity building, Plant Genetic resources conservation, research, development and production of plant variety.



#### **Principles of Plant variety Development**

- 1. To Ensure the centralized and uniform protection and utilization of Plant variety in the country wide;
- 2. To conserve, preserve, develop, protect and Plant genetic resources in compliance with the international Convention of which Lao PDR becomes a signatory member;
- 3. To ensure benefit of the State, collectives, farmer households, domestic and foreign entrepreneurs.

### **International cooperation**

- The Government supports to enhance cooperation with foreign countries, regional and international organizations in the field of Plant Variety Development;
- To strengthen exchanges of experiences, information, sciences, technology, upgrading technical levels participation to, and implementation of Conventions and Agreements of which, Lao PDR is a signatory member.


