







### **Organization System**





The income effects referring to major arable crops are just part of the overall impact.






→ Whereas approximately USD 3.5 billion have been added to GDP when looking at rice, corn and sweet potatoes, ...


→ ... an additional GDP of at least USD 0.2-0.3 billion has been added by having invested ten years into plant breeding for flowers.

→ Indeed, Viet Nam has become one of the fastest growing flower markets.

### Vietnam's applications: Private and Public sectors




Positive impact to SMEs

- Before PVP: almost of them are trade company (not interest in RD)
- When PVP system is established:
  - Beginning: they are licensed to exploit PBR from owner (transferred)
  - They develop breeding facility
- Now, many of them have own breeding facility
- Some become big with very good breeding facility.

## Policies on promoting of IP (including PVP)

- On 14<sup>th</sup> June 2016, PM of VN signed Decision No 1062/QD-TTg for the Policies to develop IP (including PVP)
- This based on 2 stages before from 2005-2010 (phase 1); 2011 – 2015 (Phase 2)

#### Purpose of the program 2016 – 2020 (1062/QD-TTg)

- Improving aware for the relevant persons
- ✓ Training (≥1000 persons from Research Institutes/Private companies/Universities)
- ✓ To support on exploitation and practical application for ≥ 50
   IPR (Including PBR)
- ✓ To support on protection, management and development for IPR of ≥ 70 local products
- ✓ To assist ≥ 100 companies/Techno-Science Organizations in developing and implementation of management model and development of their IPR
- Assisting to file IPR in VN and Oversea for the National Products those approved by Prime Minister

#### Strategy to develop VN's IP until 2030 (drafting)

- General purpose: "A Modern National IP System become a tool to speed up the National Economy"
- > Specific purposes:
  - Quantity and Quality of IPR from Vietnamese is increased
  - Capacity of IP Authorities Office is improved
  - Decrease of the infringement;
  - The measures of punishment will be mainly based on justice
  - Administrative procedures is simple
  - The No of corporation using IPR products for the development is increased
