

Outline of PVP System – PVP Law


- Enactment of new PVP act in 2013 (separated from 'Seed Industry Law')
 - **Revised contents**
 - 1) Restore PVP right
 - If the rights loss is due to unpaid PVP fee, payment within 3 months can be possible to restore PVP right.
 - 2) Strengthen PVP right
 - Strengthen the penal regulation of the infringement.

As of 1 June, 2012, Seed Industry Act was separated to Seed Industry Act and Plant Variety Protection Act. The both were enforced in June 2, 2013








Applications by year




Applications by Crops (2016. 7.)




Top 10 Application Crops (2016. 7.)




Applications by applicants (2016. 7.)



Foreign Applications (2016. 7.)




Registration by Crop Category
