1. Background and Context

- Agriculture is an important industry in many East Asia countries, and a major source of employment and incomes for a large proportion of the population.
- New, improved varieties of plants are an essential factor in agricultural development. Breeding plant
 varieties with improved yield, more efficient use of nutrients, resistance to plant pests and diseases,
 salinity and drought tolerance and better adaptation to climatic stress can sustainably increase
 productivity and product quality, ultimately leading to higher incomes for farmers and the development
 of local industries.
- An effective plant variety protection system is essential for the creation of these new varieties. However, the benefits of PVP have yet to be recognized by many stakeholders in these countries. In order to achieve the goal of agricultural development, it is important for key policy makers to have a better understanding of PVP.

2. Objective of the International Seminar

- The primary aim of this International Seminar is to provide an opportunity for key policy makers to
 move forward to UPOV accession by sharing experiences on challenges and benefits to promote
 agricultural development and giving inspiration on the role of plant variety protection under the UPOV
 Convention.
- In this program, the invited prominent speakers and panelists, such as a policy maker, a farmer, a breeder, and international organization, will share their experiences in terms of the importance of the PVP system, which would encourage and inspire all those who are facing difficult challenges in their journey to establish a robust PVP system at the international level.
