1. National goal (10-year strategic plan 2018-2027)

- The protection of new variety of plants as a form of Intellectual property (IP) is an important stimulus to private investment in plant breeding and the introduction of protected varieties for production and marketing.
- The introduction of plant variety protection, companies or their local agents are encouraged to conduct trials of new varieties in the main production areas or in the research stations.
- The regional cooperation and harmonization on application, examination and granting procedures towards the effective PVP system for the breeders in the region should be promoted and strengthen.





2. Objectives with analysis of challenges (for next 3 years)

2.1 The main activities 2022

- Strengthen the capacity of national competency authority in PVP system, DUS examination and report writing for plant breeder's application, examination and granting procedures which align to UPOV International guideline.
- To Develop and translate for documenting the DUS examination guideline for some potential crops such as cucumber, yard long bean, lettuce, tomato, water melon, chili aligned with International UPOV guideline,
- Coordinate and facilitate the registration of fours variety of cashew tree into the national variety list of Cambodia.

- Raising awareness of the joint-declaration on New Plant Variety Protection between MAFF and MTIS,

- Study visits of national competency authority to learn the experience in implementing PVP, DUS test and seed quality control in the regions (Proposed).
