












- 新修订《种子法》于2015年11月4日在第十二届人大常委会上通过并于2016年1月1日实施。 Seed Law's amendment was approved by the 12th CPC in Nov. 4th, 2015, and it has been implementated since Jan. 1, 2016.
- 新修订《种子法》对植物新品种保护工作的影响有: Seed Law amendment in relation to PVP as follows:
 - ▶ 提升了新品种保护的法律地位 Raised PVP legal position
 - ▶ 将DUS测试确定为品种管理的基本技术要求 Clarify DUS test as basic technical requirements in variety management
 - ▶ 加大了对品种权侵权行为的处罚,赔偿的数额明显提高 Strengthen the panishment for PVP infringement, the amount of compensation raised significantly
 - ▶ 明确了县级及以上农业行政主管部门责任 Clarify the duties of agricultural administrative departments at county level or above






