COVID-19 pandemic measures

- March 17, 2020
 - UPOV premises closed except for essential personnel
 - Remote working (excellent WIPO IT support)
 - Official travel cancelled
- June 2 – Sep. 30, 2020
 - No official travel outside Switzerland
 - Phased return by all UPOV staff (except vulnerable staff)
 - Remote working option for up to 3 days/week
- November 2, 2020
 - UPOV premises closed except for essential personnel
 - Remote working

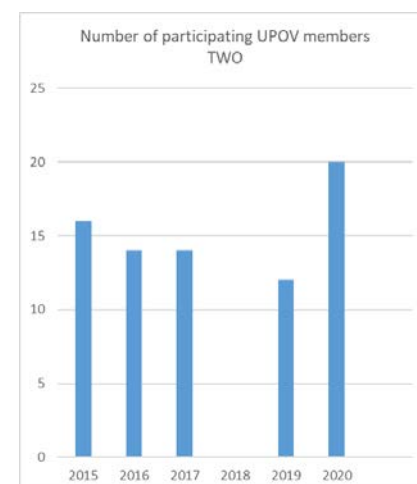
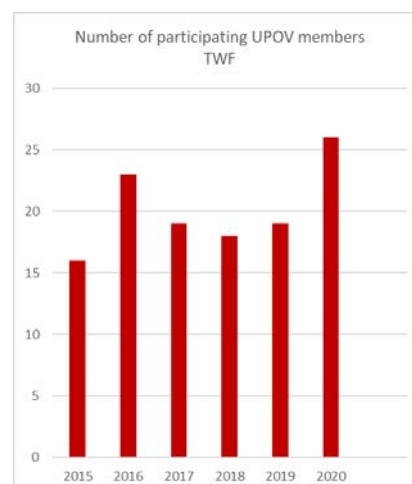
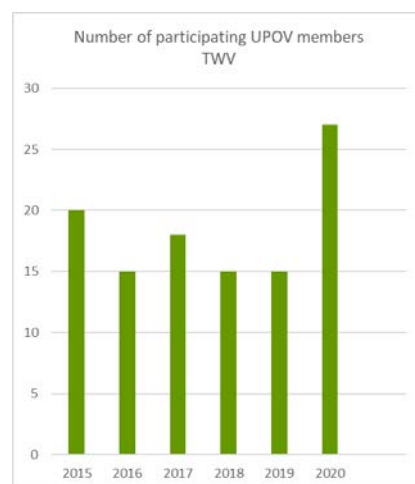
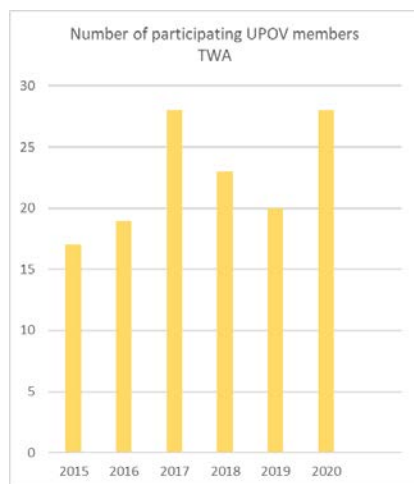
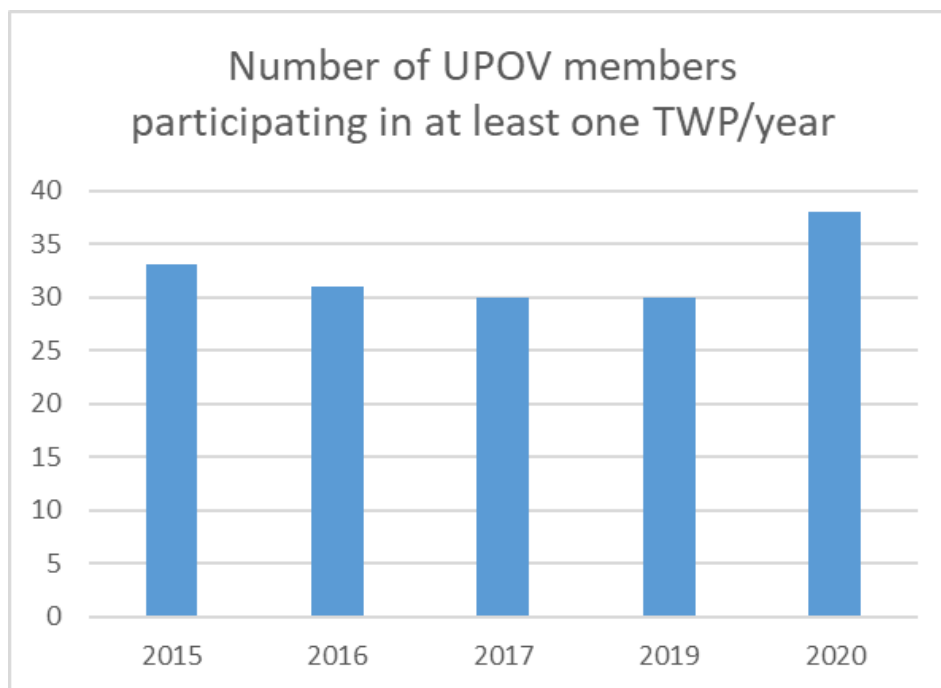
COVID-19 pandemic measures

- UPOV meetings since March 17, 2020
- Virtual meetings as planned
 - Enlarged Editorial Committee (March 24)
 - Fifteenth Meeting on the Development of an Electronic Application Form (EAF/15) (March 26)
- Technical Working Parties
 - agreed by TWP Chairpersons, after consultation with the TWP hosts and the TC Chairperson, to hold the TWP sessions by electronic means
- UPOV Sessions in October 2020 held in the form of **virtual meetings**, in combination with **prior consideration of documents by correspondence**:
 - Technical Committee: TC/56, (October 26 and 27)
 - Administrative and Legal Committee: CAJ/77, (October 28)
 - Consultative Committee: CC/97, (October 29)
 - Council: C/54, (October 30)

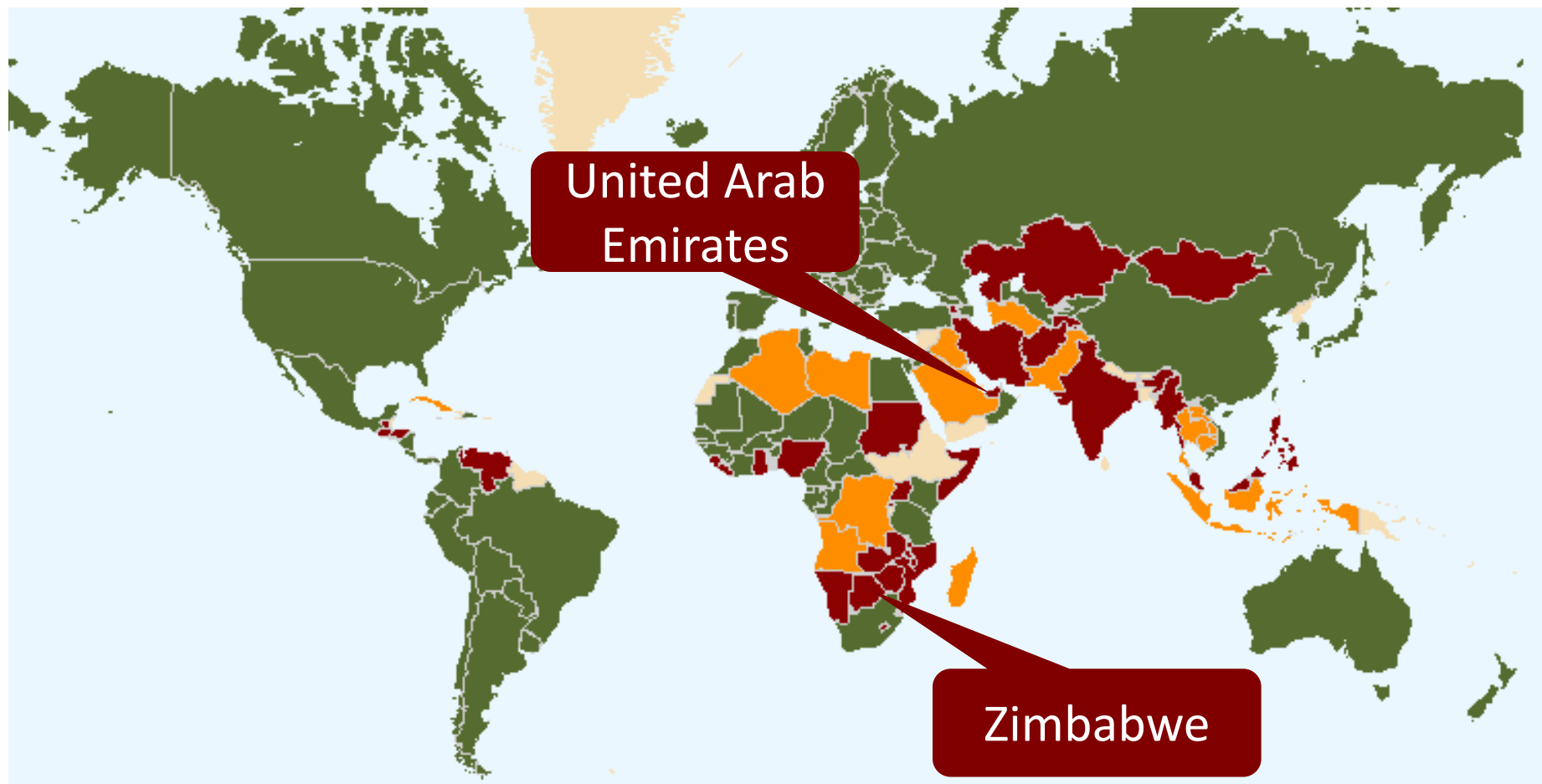

UPOV MEMBERSHIP PROCESS

- Policy decision to draft legislation in accordance with the 1991 Act of the UPOV Convention
- Contact the Office of UPOV for assistance provision of the Drafting Guidance Document INF/6 and consultations
- Finalize the Draft Law for its examination by the Council of UPOV
- Ask advice of the Council of UPOV
- If advice positive and Law in force deposit instrument of accession to become a UPOV member

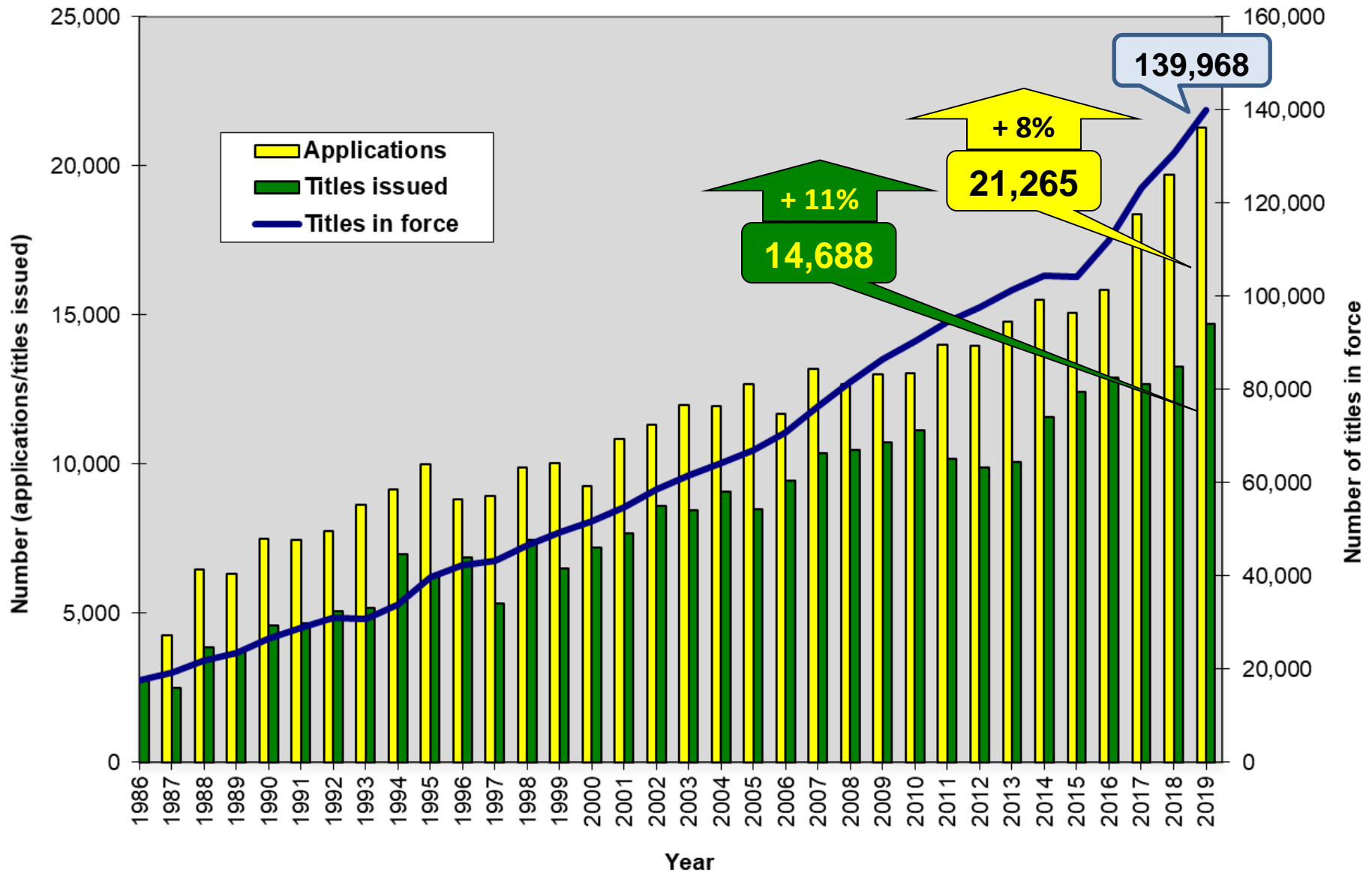
Examination of draft laws in 2020 (positive decisions)



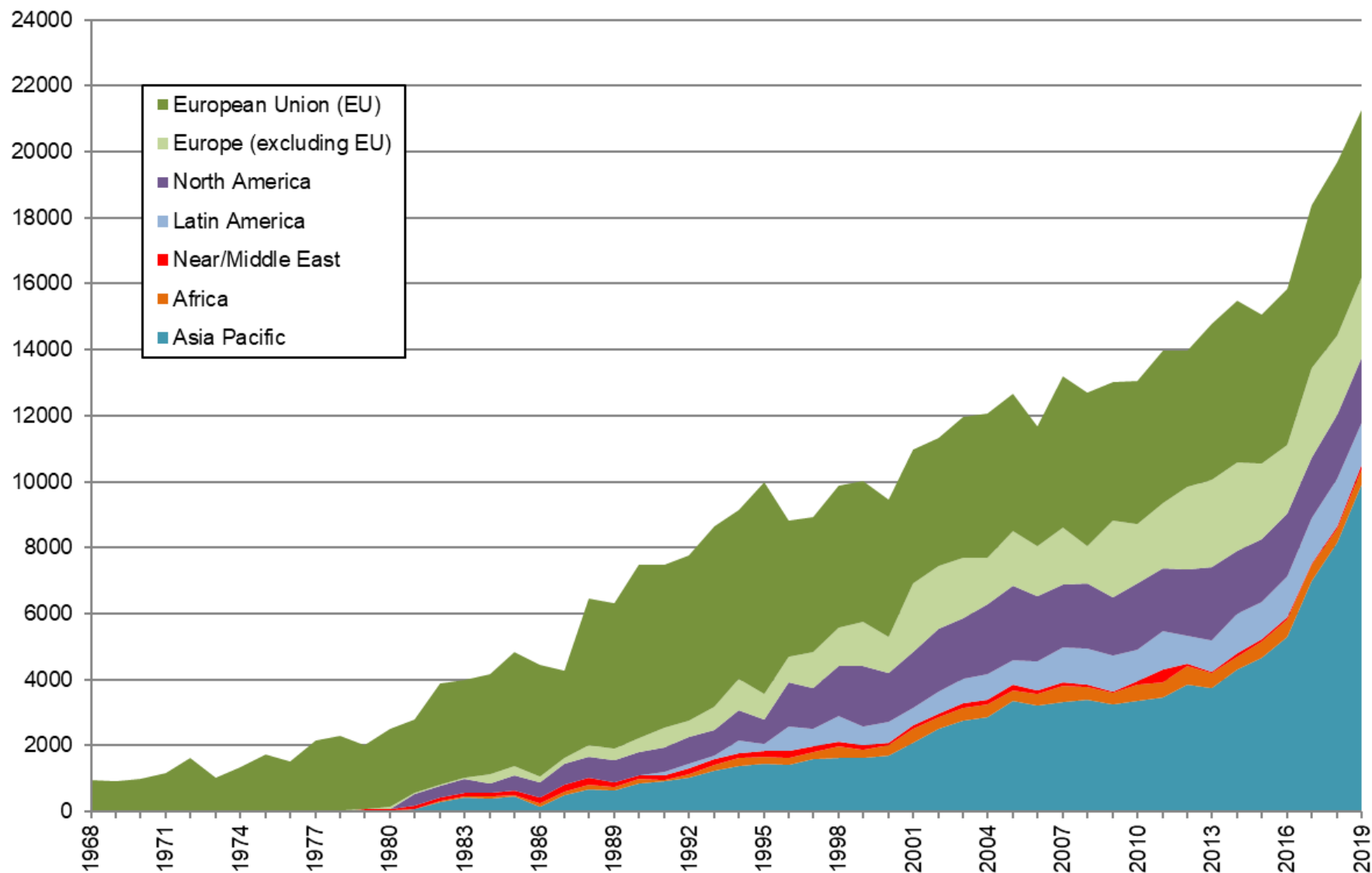

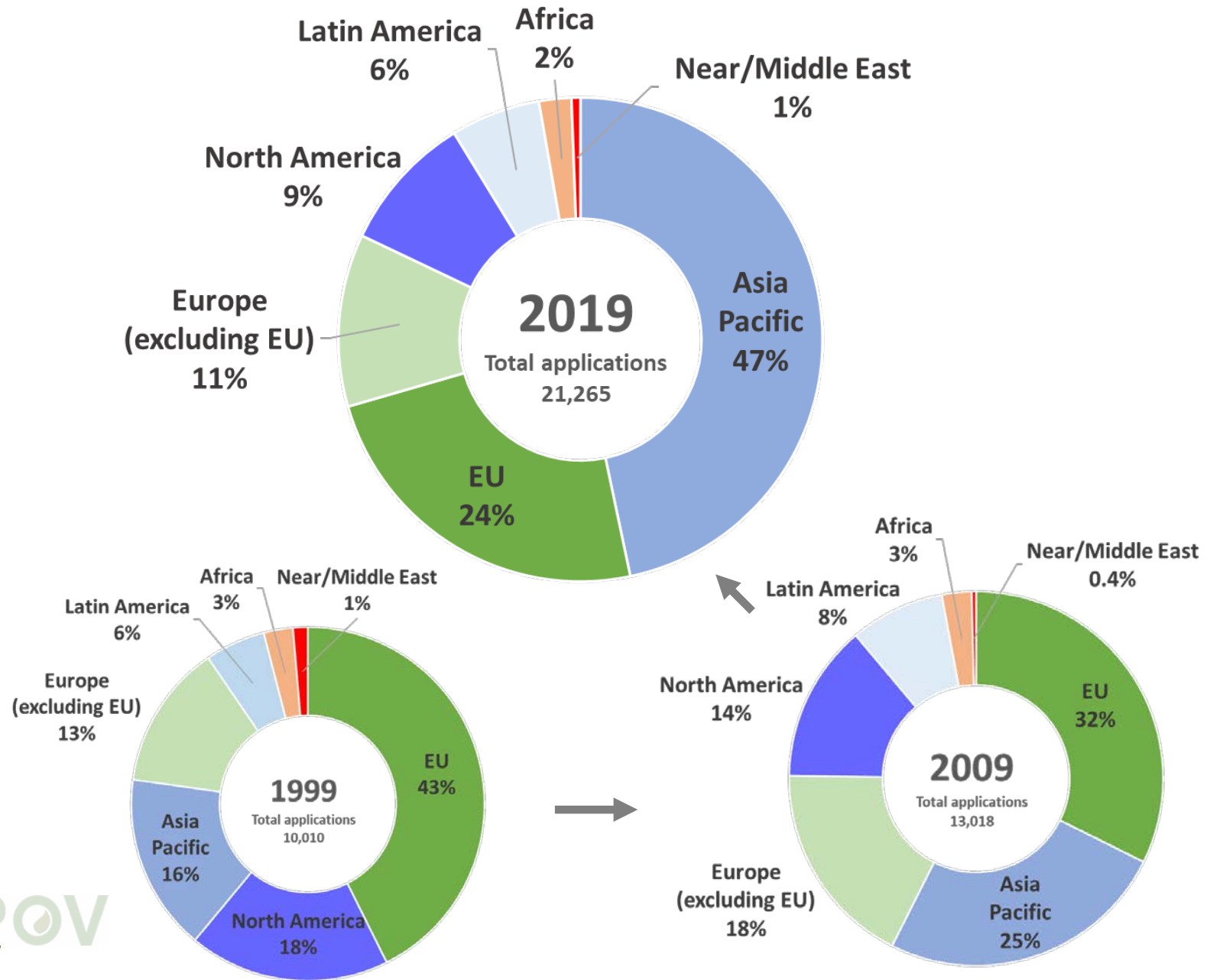
Total Applications filed and Titles issued



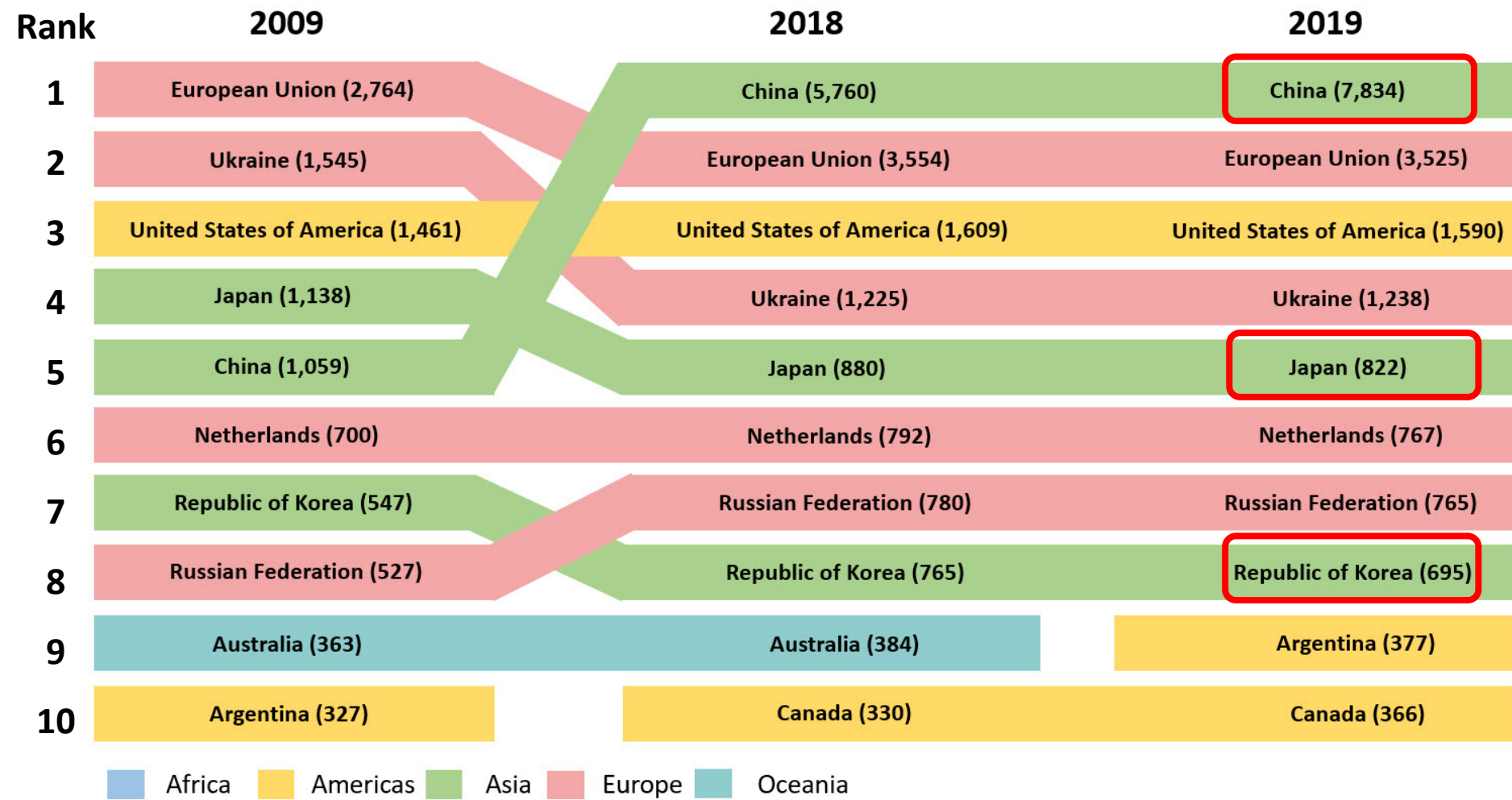
Applications received by Region

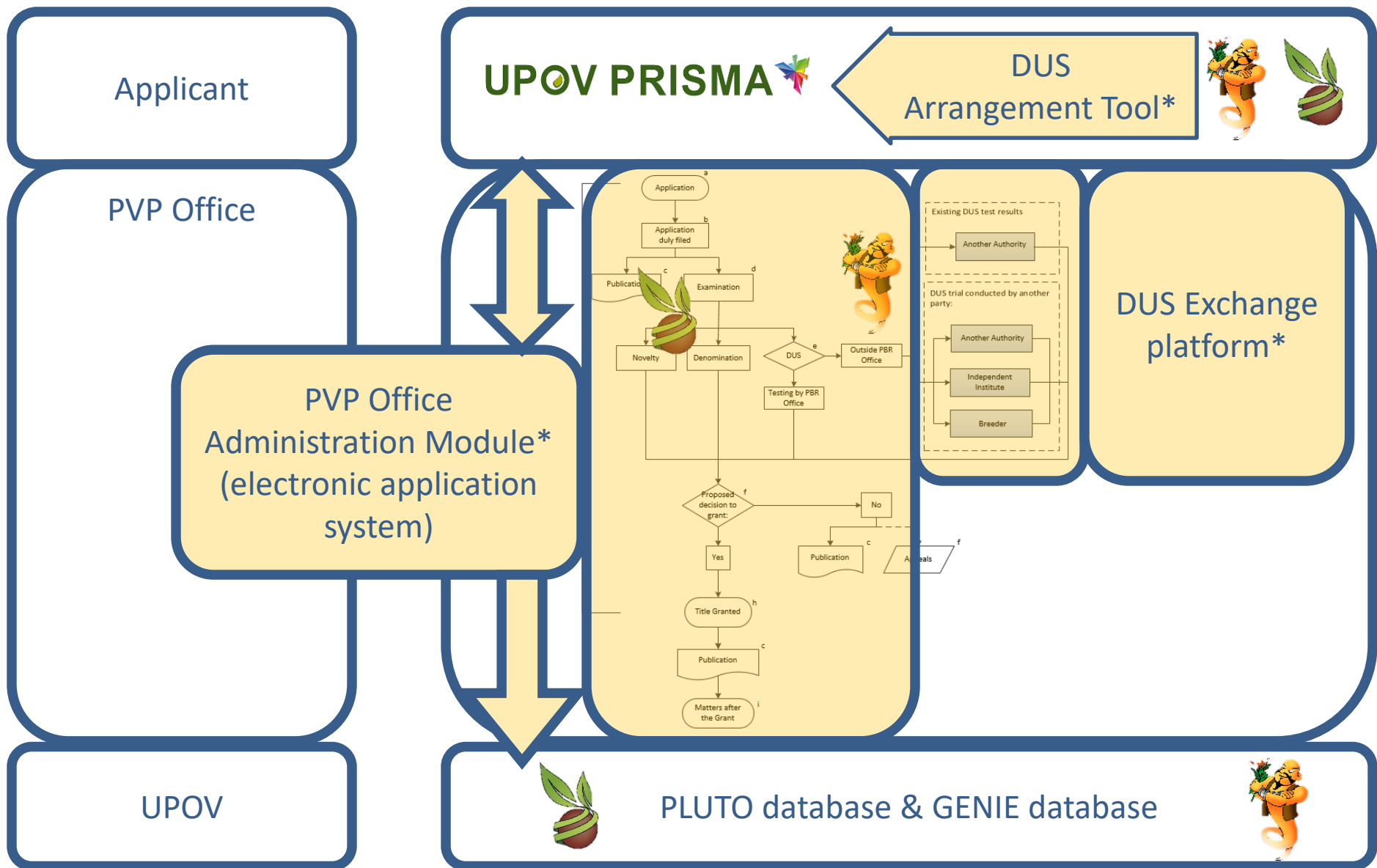
