FARM-SAVED SEED PRACTICES IN MALAYSIA



Smallholder Farmers

Mainly rice; Some root crops, vegetable, black pepper Non-Commercial, Self Subsistance



Mainly rice; Others: Flowers/ Root crops (tapioca, sweet potatoes), fruit (papaya), vegetables Commercial, Selling harvested material



Medium Domestic Farmers

Rice, Fruits (Pineapple), Root Crops, **Commodity Crops** Commercial, Seed buying, sub-licensee



Exporting Farmers

Floriculture, Fruits (Pineapple) Commercial, Licensing activities, Licensee of parental materials

AGROFOOD CROPS (Rice, Fruit, Vegetables, Coconut, Floriculture, Spice, Herbs)

COMMODITY CROPS (Oil Palm, Rubber, Timber, Cocoa, Black Pepper, Tobacco)

PROTECTION OF NEW PLANT VARIETIES ACT 2004

BREEDER'S RIGHT LIMITATION Non-Commercial Basis

- Self consumption, Ritual activities, private purpose Section 31(1)(a)
- Propagation using FSS planted on own holdings for consumption. Section 31(1)(d)

FSS Limitation < 0.2 ha size of operation holding

Scope of Activities

- Propagation using FSS planted on own holdings for <u>seed</u>. Section 31(1)(d)
- Exchange among small farmers Section 31(1)(e)
- Sale of FSS due to disaster Section 31(1)(f)


